

SUMMARY DATA FACE-DR

FondaMental Advanced Centre of Expertise – Dépressions Résistantes

FACE-DR (FondaMental Advanced Center of Expertise – Resistant Depression) is a clinical database built from the computerized medical records of the FondaMental Expert Centers for Resistant Depression.

This summary is intended for all teams wishing to access the **FACE-DR** database data to implement, develop, or promote a research project. It summarizes, in a non-exhaustive manner, all the data available in the **FACE-DR** database, classified by major themes.
